They will be read and voted on to send to Supreme for approval

Proposed changes to the By-laws for Fr. Gerard Powers Assembly 2882  
March, 2010

Faithful Navigator: Clark Hill, PGK  
Committee Chairman: Joseph LaGuardia, PGK, FDD, Faithful Captain  
Committee Members: Joseph Menicola, PFN, GK  
John, Dan Poulter  
Alfred (Duke) Margo

Article III – Sect.1, of our by-laws, Officers: Reads “and three trustees”. Supreme Laws & Rules: Article VIII sect. 8, our by-laws read; “and a three year trustee”. Change to Supreme reading.

Under Officers, reads; “The faithful Comptroller shall collect and receive all monies due the Assembly and all funds obtained from any source and transfer the same to the faithful Purser and obtain a receipt from that officer, he shall keep accounts of the charges and receipts of each member, (we wish to ADD), including a separate and accurate account of those participating members of the “Chalice Fund”.

Article V - Committees- Admissions Committee, reads-“Admission Committee consisting of seven members of the Assembly.” Want to change it to: “Consisting of three members of the Assembly.”

Article VII - Dues: “Reads, the dues shall be fifteen dollars per annum.” Want to change to; “the dues shall be twenty dollars per annum.” (NEW): “members wishing to take part in the optional “Chalice Fund”, including Honorary and Honorary Life Members, shall be assessed an additional \$10.00 per annum. Please refer to Supreme Laws and Rules Governing the Fourth Degree Knights of Columbus, Article IX, Membership, section 36, for more information regarding Honorary and Honorary Life Membership requirements.

Article VIII – Funds: Section 6 calls for a relief fund of \$100.00 for a brother in distress. (We would like to eliminate the entire section as the Assembly will take under advisement any brother in distress and donate according to the available funds.)

Article X - Death of a member: Para . 1, reads; “member in good standing, ten memorial Masses.” (Change to “one memorial Mass.”)

Paragraph two: Reads, “The gift of a chalice or other religious memorial shall be made by the Assembly to a church or Priest as selected by the deceased member’s family.” Would like to change it to read; “The gift of a chalice, shall be made by the Assembly to the family in memory of deceased member in good standing in the “Chalice fund”.
